Public Comment	<p>Members of the community advocated for CalMHSA’s Supervisor of Peer worker training to be longer and to have knowledge checks to ensure everyone absorbs the materials.</p> <p>Members of the community also advocated the Best Practice Guidelines to be Peer centered and have the voice of peer run organizations. A Stakeholder member also asked what the non-negotiable items are in order to be able provide CalMHSA with adequate feedback.</p>
