# Budget

The RFP states that "training costs will be covered through a fixed budget. If awarded, is the contract a cost-reimbursement contract or deliverables-based contract? How will the funding amount be determined?

The total funding amount will depend on the number of participants trained, as determined by the approved cohort sizes and the total participant count allocated to the awarded training provider(s). Payment will be invoiced by awardee based on number of participants trained, per terms of Agreement.

# Funding

If paid per participant, what happens if someone does not complete the training?

Funding may be determined through a combination of both participant attendance and successful completion of the deliverables, ensuring flexibility and alignment with training goals. The funding is based on a fixed budget cost.

# Virtual Training

Is there a time period in which the virtual portion of the training needs to be completed? Does it need to be completed in five consecutive days? Does it need to be completed in the week following the in-person training portion?

The first 40 hours of the training are required to be in-person. The virtual portion of the training does not need to be completed in five consecutive days, but it must be completed

within the overall program timeframe of January through February 2025.

Training Providers are encouraged to structure the virtual training in a way that supports participant engagement and accommodates their schedules. While the specific timing of the virtual portion is flexible, it is recommended that the virtual training begins shortly after the in-person training concludes to maintain continuity and engagement.

Participants must complete the entire 80-hour program (including both in-person and virtual components) within the required timeframe to meet program goals and certification requirements. Training Providers should communicate clear timelines and expectations to participants to ensure timely completion.

# **Cohort Size**

What is the minimum number of cohorts an organization can propose to provide and still be considered for an award?

There is no specified minimum number of cohorts an organization must propose to provide in order to be considered for an award. However, the ability to deliver high-quality training to meet program goals will be a key evaluation factor. Organizations are encouraged to propose the number of cohorts they can realistically and effectively manage within the program's January–February 2025 timeframe.

Is there a minimum number of participants required in each cohort?

This information is under review; however, the facility capacity will be taken into consideration for in-person training cohorts to ensure program cost-effectiveness and efficient use of resources. Proposals may demonstrate the ability to train larger groups and manage multiple cohorts within the timeframe, as applicable.

No. The intention is for multiple organizations to receive awards. CalMHSA seeks to collaborate with multiple training providers to ensure the successful delivery of training to 1,050 individuals across California. This approach allows for geographic and logistical considerations, ensuring training accessibility for participants statewide.

Each training provider is encouraged to propose the number of cohorts they can realistically and effectively manage within the program's timeline. Proposals will be evaluated based on the provider's capacity, expertise, and ability to meet program objectives.

CalMHSA will provide the training provider with a list of participants who have been selected to attend the training. Participants will be assigned to specific training cohorts based on logistics such as location, training schedule, and other considerations to ensure equitable access and program success.

Can the Contractor also recruit participants for the training?

Contractors may NOT independently recruit participants for the training. All participants must be referred and approved through CalMHSA's established process to maintain consistency and ensure alignment with program goals and requirements. Contractors are expected to coordinate with CalMHSA on participant communication, enrollment, and

#### Internships

Participants selected may be individuals who may or may not yet be in the peer workforce. Participants referred by CalMHSA may have varying levels of work experience Participants must not yet have a Medi-Cal Peer Support Specialist Certification.

# Work experience?

Participants referred by CalMHSA may have varying levels of work experience. While some participants may have prior experience in behavioral health or peer support roles, others may be new to the field. The Medi-Cal Peer Support Specialist training program is designed to equip participants with the knowledge and skills required to meet the certification requirements, regardless of their previous work experience.

Training providers are encouraged to use instructional strategies that accommodate diverse backgrounds and experience levels to ensure all participants can succeed in the program.

The primary goal of this program is to increase the number of individuals in the peer workforce by equipping participants with the knowledge, skills, and certification required to become Medi-Cal Peer Support Specialists. The program is focused on expanding and strengthening the peer workforce across California to meet the growing demand for peer support services in behavioral health settings.

While the program includes time-bound objectives to ensure participants are prepared for



the workforce efficiently, the overarching purpose is workforce development and the enhancement of services available to Medi-Cal beneficiaries. Training providers are expected to deliver high-quality, accessible, and engaging training programs that meet certification standards and align with the long-term goal of workforce expansion.

The Contractor is required to deliver the approved 80-hour Medi-Cal Peer Support Specialist training curriculum that has already been approved for their agency. This curriculum must include the following components:

- 1. In-person Training:
  - a. Deliver the first 40 hours of in-person training over five consecutive days
  - b. Ensure participant engagement and accessibility for all individuals during training sessions.
- 2. Virtual Training:
  - a. Deliver the next 40 hours of virtual training.
  - b. Ensure the training aligns with the 17 core competencies for Medi-Cal Peer Support Specialists as established by the Department of Healthcare Services (DHCS).
- 3. Curriculum Fidelity:
  - a. Use the approved training materials without modification to the content, except for administrative or organizational adjustments necessary for hybrid delivery.
  - b. Adhere to all guidelines, policies, and standards set by CalMHSA for Medi-Cal



Peer Support Specialist training.

- 4. Compliance:
  - a. Follow all safety and accessibility standards for in-person training.
  - b. Ensure the virtual training platform meets technical and accessibility requirements to support participants with varying needs.

By delivering the approved curriculum, the contractor will help equip participants with the knowledge and skills required for certification and their future roles as Medi-Cal Peer Support Specialists.
